Refugee Cases

The Immigration and Refugee Protection Act allows foreign nationals to apply for refugee protection while outside Canada and to be selected for resettlement in Canada. CIC's Refugee and Humanitarian Resettlement Program reflects Canada's commitment to protect refugees and people who are in refugee-like situations. Either CIC, groups of Canadian citizens or permanent residents may sponsor refugees

Temporary Foreign Worker (Temporary Work Permit)

Under the *Immigration and Refugee Protection Act*, foreign nationals may work temporarily in Canada under certain conditions. Those who wish to do so are generally required to have a work permit, which is usually valid for a specific job and length of time.

International Adoption

The Canadian immigration process enables a Canadian citizen or permanent resident (18 years of age or over and living in Canada) to sponsor a child who has been adopted outside Canada, or who will be adopted in Canada. In addition, a Canadian citizen who has adopted a child while living abroad, and who is preparing to return to Canada, may sponsor that child to come to Canada.

Group Sponsorship

Under this category, group of people are sponsored for business / educational / exploratory / entertainment etc purposes. Our services include providing Canadian promoters, preparation/execution of contract/agreement, sponsorship application, approval etc

Citizenship
